Notification regarding conduct of Training of Trainers ToTs

ISLRTC, New Delhi, an autonomous body under DEPwD, MSJE, Govt. of India has planned to conduct a three-day non-residential Training of Trainers (ToTs) from 4th-6th August 2022 at India International Centre (IIC), New Delhi. The nominations are invited from Deaf ISL Instructors/Master Trainers only who are intended to undergo the ToTs.

2. ISLRTC receives requests from various stakeholders to conduct short term ISL training, awareness and sensitization programme on ISL etc. Hence, the purpose of the ToT is to polish the skills of already certified ISL instructors so that standard curriculum is taught and quality is maintained while providing training to various stakeholders. All the participants of ToTs who are issued a certificate from ISLRTC may get a chance to be empanelled on an ISL Instructor panel of ISLRTC so that there is a ready resource for appointing qualified and ToT certified instructors for various training to meet the demands of ISL training from various stakeholders.

3. The details of the training programme are as under:

Eligibility: The candidate should have passed ISL 'C' level or DTISL course approved by RCI.

Topic: Training of Teachers (ToTs) for Deaf ISL Instructors/Master Trainers

Duration: Total training time is 18 hours – divided into three days with six hours training per day.

Intake: 50 Participants only

Dates of Training: 4th-6th August 2022

Training timings: 10.00 am- 05.00 pm (Inauguration starts at 09.00 am on the first day)

Venue: India International Centre (IIC), New Delhi

Note: The registration fee is non-refundable. If ineligible candidates apply for the ToTs, no refund will be made. Hence, the sole responsibility to check the eligibility criteria to join ToTs will be of the candidate.

4. The nominations will be accepted through Google form after paying the requisite registration fee on 'first come first served basis'.
5. The three-day ToT is non-residential so the candidates need to arrange for their lodging and boarding themselves. Only the lunch and two time tea snacks will be provided during the training.
6. Final list of the participants will be uploaded on our official website www.islrtc.nic.in on 25.07.2022.
7. In order to motivate already trained and certified ISL trainers, the Centre has planned to provide an incentive honorarium of Rs. 2000/- to each participant for the entire training after completion of ToTs.
8. Certificate will be issued to the participants after the completion of three-day ToTs.
