4. An English skill test will be conducted to determine proficiency levels of the candidates, followed by an interview. The candidates will be required to do a demonstration of teaching English to deaf students.
5. The Competent Authority reserves the right for any amendment, cancellation or change in this advertisement in whole or part thereof without assigning any reason.
6. No TA/DA will be admissible for appearing for the interview or for joining the Institute.
7. The incumbent will be paid the fixed amount of salary as mentioned in the advertisement. No other allowance such as DA/HRA/etc. and other allowance will be admissible.
8. This engagement will be purely temporary for a period of 03 months/01 year on contractual basis. However, contractual engagement may be terminated any time at the discretion of the Competent Authority, ISLRTC without assigning any reason thereof.
